6. Morbidity and Mortality Council



Dr. Pillai gave an update of the Morbidity and Mortality Council. Cases discussed included cases related to potential sepsis and treating appropriately. Dr. Pillai shared that in one case the patient had subtle changes in vital signs heading towards sepsis and a positive SIRS. The patient could have benefited from broad spectrum antibiotics, aggressive fluids and a lactic acid draw.

7. Perinatal Committee

Dr. Lewis shared an update of the Perinatal Committee. Policy updates were approved. For breastfeeding measures, initiation among the black population were down. A focus with this measure needs to be on meeting patients where they are with education etc. Ms. Federico shared with the department hospitals are experiencing transportation issues across the state affecting transfer of critical patients. With the closing of Tufts PICU, there is also a decrease in beds available causing pediatric patients to be here longer.
