I. Call to Order

• Dr. Pillai called the meeting to order at 7:00am.

II. Approval of Minutes

• The department approved the previous minutes of September with edits that Dr. Pillai emailed about.

III. New Business

- A reminder that all workforce members are required to receive the flu vaccine by the end of the month.
- Dr. Pillai sent a link of the current Flu Clinic dates being offer through out Tufts Medicine. There are dates at Saints Campus as well as Main Campus.
- If you get your flu shot at one of the listed Clinics then it will be automatically recorded, and Occupational Health will have the information.
- Employed physicians with a Tufts Medicine email address will need to upload their flu vaccines records into PureOHS if you are getting it from an outside vendor.
- If you are not employed or do not have an active Tufts Medicine email, you can email your vaccine records to OccupationalHealthLGH@tuftsmedicine.org.
- A signed declination needs to be signed if not receiving the COVID vaccine.
- Point32Health is now Tufts Health Plan and Harvard Pilgrim Health Plan combined.
 They are prorating the cost of contracts for the rest of 2025 and Dr. Pillai told the department that she recently accepted a contract.

IV. Old Business

a. Medical Executive Committee

- The Chief of Pediatrics informed everyone on the RSV guidelines which state that a mother can only receive the RSV vaccine once.
- There seems to be a low use in ambient Al within Lowell General Hospital so far.
- It is also known as Dragon Ambient Experience or DAX.



- They are attributing to the low turnout due to it only being available on Apple iPhones. However, in November of 2025, DAX will be available on Androids as well.
- Back in June, Dr. Frank Osborn, the Ambulatory CMO announced that all ambulatory physicians and advanced practice clinicians are eligible to use DAX
- It is an Al generated application on your phone that will transcribe your notes in real time.
- Those interested in potentially using it will need to fill out a questionnaire to get access.
- Dr. Holmes mentioned that she uses it and said that there are adjustable settings. She likes concise notes.
- Paloalto Global Protect VPN will be replacing the Citrix VPN. You will need to download this in order to access Epic remotely.

b. Labor and Delivery Committee

- Dr. Holmes informed the department that the Labor & Deliver Committee have been working on is creating outpatient cervical ripening protocols which would include starting inductions outside of the hospital.
- The Committee has also been working on a new Bladder Urinary Retention Protocol which would mean intervening sooner than a lot of physicians typically would, which is what newer evidence supports.

c. Cancer Committee

No one was on the call to give an update.

d. Credentials Committee

• Dr. Marshall informed the department that there were no major updates.

e. Morbidity and Mortality Council

No update was given.

f. Perinatal Committee

• There were no updates on Perinatal Committee as they meet next week.

g. MCH Updates

• No updates were given.

h. DEI Update

- The mentorship program is in effect starting the 1st of this month. There have been the most applications received in the history of the program so there has been a challenge matching everyone but luckily everyone was matched.
- There might be some requests to have a mentee shadow for one day or a half day.

i. Family Medicine Residency Program

 Dr. Marshall said that the first round of interviews started yesterday and went very well. Interviews will continue throughout the next couple of months.



j. Bridge Clinic

No updates were given.

k. Mass Medical Society

 Dr. Dulac said to look out on the Mass Medical Society website for the registration for the Fall Meeting.

I. Inpatient Care Update

- Dr. Pillai introduced Dr. Roberto Larios to the department who is actually a long term member of the medical staff at Lowell General Hospital.
- Dr. Larios works for the hospitalist group and is also a Family Medicine physician as well.
- He has worked at Lowell General Hospital since 2014 and works as an adult hospitalist and nocturnist in Critical Care in the ICU.
- Dr. Lario expressed interest in teaching when the Family Resident program is up and running.
- He did his medical training and schooling in Columbia and originally studied Anesthesiology. He has extensive training in Anesthesiology.
- He did his Family Medicine Residency and UMass in Fitchburg.

V. Vascular Services and Referrals

- Dr. Pillai invited Dr. Swati Chaparala to the department meeting to discuss the new Vascular and Vein Center that opened which is a collaboration between Tufts Medicine, Lowell General Hospital, The Vascular Care Group and Commonwealth Radiology.
- Dr. Chaparala is a board certified vascular surgeon and earned her medical degree from Northeast Ohio Medical University and did her residency in Vascular and Endovascular Surgery at the Mayo Clinic in Rochester, Minnesota.
- She served as an assistant professor in Division of Vascular Surgery and the University of Maryland School of Medicine.
- She works closely with Dr. Oriel who is also a vascular surgeon. Some other
 physicians that work in the clinic are Dr. Gregg Franco and Dr. Allan Hoffman
 who are both Interventional Radiologists and Dr. Nathan Riddell who is an
 Interventional Cardiologist. Dr. Paul Burke is also a member of the group who
 does mostly sees patients in the clinic and does wound care.
- The Vascular and Vein Center is a full clinic with procedure rooms. There are
 usually two or three ultrasound technicians working per day doing vascular
 ultrasounds in the outpatient based lab where they are able to do catheter based
 procedures.
- Dr. Chaparala discussed the conditions treated at the clinic and include aneurysm disease, carotid disease and peripheral arterial disease.
- She emphasized the importance of early intervention and stated that the clinic offers preventative care, preoperative management and surveillance protocols.
- Various treatments are offered including angiograms, stenting, angioplasty, and embolization's to manage conditions like cerebrovascular disease.
- The slides were sent via email, and I will also be attaching them to the end of the meeting minutes.


Endo and Open AAA Repair

When to Refer: Carotid

Carotid stenosis >50%

Vertebral artery stenosis

Subclavian artery stenosis (blood pressure discrepancy >30mmHg)



When to Refer: Aneurysm

Abdominal aortic aneurysm > 3.0cm (fusiform)


Any saccular abdominal aortic aneurysm

Thoracic aortic aneurysm >3.0cm

Any visceral aneurysm

Popliteal aneurysm >1.5cm

Any peripheral aneurysm (femoral, upper extremity, subclavian etc)




When to Refer: Kidney disease

Concern for renovascular hypertension or renal FMD


Chronic Kidney Disease stage 4 or 5, ESRD with need for hemodialysis access
