Congratulations, your son/daughter has been selected to participate on a Fraser Heights Athletics team. Please be advised that all students participating on a Fraser Height team must attend practices on a regular basis, and must be committed to their academic studies at the school. Please remember that our coaches, teachers and community members, are volunteering their time. Please respect their contribution of time so you are able to have this opportunity.

The Fraser Heights Athletic Program requires that the student and the parent/guardian complete the information below and return this form to coaches in order to ensure the student's eligibility to play on a school team. In addition, all athletes and parents/guardians must read and agree to our Athletic Policies and Regulations as well as complete the online medical form. Students will not be permitted to play or compete until this form is returned and the online medical form is complete.

For sports where uniforms are required (volleyball, basketball, soccer, rugby) students must also submit the following:

1. A post-dated cheque in the amount of **\$100 as a uniform security deposit**. Uniform security deposit cheques should be dated *December 15, 2017* for fall sports and *April 1, 2018* for winter sports and *June 15, 2018* for spring sports. These are returned when the full jersey comes back to us in the same condition at the end of the season.
2. An athletic fee to the amount of:
  - o \$80 for Junior and Senior Basketball
  - o \$65 for Grade 8 Basketball
  - o \$55 for Volleyball, Soccer, or Rugby
  - o \$45 for Badminton or Dance
  - o \$25 for Cross Country, Track and Field, Swimming, Tennis, and Ultimate
  - o \$10 for Golf and Hockey

\*\*Please note that there is no reduced rate for playing multiple sports  
\*\*Please note that these are minimum costs and teams may pay more based on costs per season (number of tournaments entered and any travel costs)  
\*\*The athletic fee includes your ticket to our end of the year Athletic Evening

Please keep in mind that Fraser Heights' athletes are held to the highest of expectations in terms of their personal conduct and that participation in high school activities is a privilege, not a right.
